CITY OF AGENCY PROPERTY IMPROVEMENT

He asked the city to decide if the money should be spent on tuckpointing City Hall, buiding on to the city shop or he had also heard of a building coming up for sale inside of Agency that already has heat, water and electricity. Ms. Deshler asked how much to purchase the building. Mr. Clubb answered that it wasn't officially listed for sale but he thought it would be \$125,000. Mr. O'Brien asked if the horseshoe pits would be in the way of adding on to the city shop. Mr. Clubb advised that no when he installed them he left space. Mrs. Ulin asked if the smoking pit would have to be filled in. Mr. Clubb advised yes. Mr. Douglas advised if we would have to heat the whole building. Mr. Clubb advised no only the addition. Ms. Douglas advised that she would like to see estimates for the next meeting.

TAKE HOME USE OF CITY TRUCK DUE TO ON CALL STATUS FOR MAINTENANCE DIRECTOR

Mayor Johnson advised that Fred Clubb would like permission to take the city truck home each day due to being in on call status every day. Mr. Clubb has advised that he is willing to forgo his raise this year if he is granted permission to take the truck home each day. Mayor Johnson advised there are two other trucks to drive if that were to happen.
