The regular meeting of the Agency City Council was called to order at 7:00 pm by Mayor Jake Johnson at City Hall. APPROVE OR AMEND AGENDA:

Ms. Deshler motioned to approve the Agenda. Second by Ms. Douglas. All Ayes. Motion passed.

CONSENT AGENDA

Mr. O'Brien motioned to approve the Consent Agenda. Second by Ms. Deshler. All Ayes. Motion passed.

COMMITTEE REPORTS

FINANCE COMMITTEE – Ms. Deshler advised everything is good.
STREETS, ALLEY, WATER & SEWER COMMITTEE – Mr. O'Brien advised there have been several water leaks at homes due to the cold weather. Mr. O'Brien further advised that the banners had been switched over to spring.

Mayor Johnson spoke about the Wapello County Board of Supervisors setting a meeting regarding emergency services in Wapello County. At this time emergency services are not required by Iowa Code. Wapello County Emergency Management has requested the Board of Supervisors recognize emergency services as an essential service.
